Clinical supervisors: Scaffolding novice professional counselors

Counselor and counseling supervision are integral in the preparation and professional development of pre-license professional counselors. Supervisors are responsible for initiating the novice professional counselor into the counseling profession, ensuring the integrity of counseling services provided to clients by the supervisee, and ultimately protecting the welfare of clients served by the supervisee. Attention will be given to the provision of supervision in-person as well as in the digital/distance environment. This session will identify the characteristics, role and responsibilities of a clinical supervisor, and the clinical supervisor qualifications necessary to support professional counselors and to protect the public. Effective counseling clinical supervisors support licensing boards in their regulatory duty and obligation.

CRCE Licensure Parity & Impact on Individuals with Disabilities

Rehabilitation Counseling is a specialization of the counseling profession with the merger between to major accrediting bodies, the Counseling on Rehabilitation Education (CORE) and the Council for Accreditation of Counseling and Related Educational Programs (CACREP), completed on July 1, 2017. While rehabilitation counselors receive the same graduate-level education in counseling fundamentals as other counselors, the profession also requires specialized coursework addressing various aspects of disability. Since the early 2000s, the accreditation and certification standards for rehabilitation counseling have been recognized as having parity with their equivalents in general counseling by the ACA (Travydas, Leahy, & Zanskas, 2009). As an entry-level exam for licensure in some states, the CRCE is viewed as equivalent to the National Counselor Examination (NCE), governed by the National Board for Certified Counselors (NBCC) and associated with the National Certified Counselor (NCC) credential.

Today, mental illness is a leading cause of disability in the United States and across the world. The demand for Certified Rehabilitation Counselors is on the rise. However, exclusion of licensure parity for CRCE across many licensing boards, including states with the highest rate of individuals with disabilities, excludes CRCs from practicing in the various settings. At a time when the need for licensed counselors is at a record high, there is no reason to unnecessarily narrow the path to licensure for those professionals who are otherwise qualified. This session will provide rationale and recent research supporting the recommendation that the CRCE be considered equitable to the NCE by state licensing boards.

The National Board for Certified Counselors, Inc. and Affiliates released the new format of the National Clinical Mental Health Counseling Examination in Fall of 2022. The exam's new format was carefully sculpted to ensure a high-fidelity examination with the test content representing a counselor's clinical case load. This session will present an overview of the examination content development including a description of item writing, narrative writing, and implementation of bias and sensitivity review. Special attention will be given to presenting the results from the initial administrations of the examination along with an explanation of scoring and standard-setting procedures and validation evidence.
